### **Item 3:** Connection: Update / Recommendations

- Thank you to Dale Davis for volunteering your time and energy to work on the connection.
- Email has been sent by Dale regarding the plan. First issue will feature herdsires offering a free ½ page ad to members to showcase their herdsires. Second issue will focus on products that ranches are producing. The third issue will be a printed directory of all current alpaca owners.

## Item 4: 2024 show update / Update on GCG and Classic show. Plus, Fleece show

- Update from Russ Mello regarding the shows. We are on track to have the 2 Orland shows. Information is available on the website.
- Fleece Show update: BOD discussed and after looking at the budget it was not cost effective to have both fleece shows. Decision made to be fiscally responsible and have one show vs 2 on different weekends.
  - Will revisit after the fall shows and talk about another option.
  - o Dale Davis stated that fleece shows tend to lose money.

## **Item 5:** Membership update

- 50 memberships in Nov, currently 43 farms, 4 new farms, 4 associate, 1 is new, 70 farm memberships, 7 pending total 77, 6 pending payment 5 are new.
- Membership committee is working on increasing membership and are encouraging farms to sponsor new farms. Important to continue educating new members.
- Suggestion to provide an electronic reminder to renew membership every year suggested by Cindy Harris. Autorenewal could be done by paypal.

## Item 5: SB 1479 – Ca Agritourism Promotion Act / AB 2635 – Same as SB 1479

- Letter was written to show that Calpaca supports the bill. Drafted by Sara Mattia prior Lobbyist.
- Bill geared toward decreasing liability for farms.

- Most committees have met and are working on making positive changes.

- #3 Membership Sheila reviewed Looking to increase membership and change different levels of membership EX: Youth, Corporate, Farm, Associate

  - Sheila reached out to Wade to do a presentation on phenotype and fiber for Calpaca will be posting date for this presentation this summer.
  - o In Feb had in person education regarding the "squeeze" technique
  - o Zoom presentations will be recorded. Free to members
- #5 Fiber Has met and will be meeting again soon.
- #6- Show Russ Mello/Michelle Ing– working on increasing participation / also talked about doing a Pen sale and herdsire showcase. Discussed opportunity and benefit of having a sale. Could also auction off additional animals.
  - Cindy Harris suggested to auction some pregnant females maybe split revenue between owners/Calpaca
