**Subject: Trailer and Show Panels Sold** 

Background

Cal-Paca purchased the trailer and about 500 4X8 lightweight fence panels in 2015 and used at shows where the facility didn't have paneling available. Over the years there was always an issue with moving the van, storing it, and the work involved by volunteers to make all this happen. The trigger to consider selling the van was when Cal-Paca had to pay for monthly storage about a year ago. Another trigger was that Cal-Paca needed to cash up its treasury.

The President of Cal-Paca established the "Dispersal Committee" to find a buyer and dispose of its largest assets consisting of a large trailer and about 500 show panels. The following is a list of questions that should answer any concerns the board members may have.

1. What individuals or entities have purchased the panels?

Menezes Hay Company 5030 Dwight Way, Livingston, CA 95334, is a private party; trailer and panels sold as a package for \$11,000. Cal-Paca is not being charged for fuel or moving costs from Merced. Trailer will be stored at the Menezes ranch until the transaction is completed with a signed bill of sale and cash in hand. Moving costs back to storage, if not sold, would have been about \$800 to \$1000. Larry will be the Cal-Paca representative and contact person on the sale and subsequent events.

2. What is going to be the net income for Cal-Paca?

The net income will be \$11,000. Total money invested was an original \$3000 price tag and one year of storage at \$1600. This \$4600 was sunk costs, so we are actually getting this money back.

3. Have contracts been written for the sale of the panels and trailer?

The title has been found but some additional DMV work has to be done to bring it current. Once completed, the sale can be consummated using a DMV Bill of Sale form. There is a requirement that has been agreed to that Menezes will deliver 250 panels (pending the Glenn Co. fairgrounds approval) to "Orland" for Cal-Paca's next Gold Country show this Fall.

- 4. How are the panels being transferred to their new landing spot and what is the charge going to be? Menezes is moving the trailer and no charge to Cal-Paca.
- 5. Are Cal-Paca members going to be offered the opportunity to purchase panels. No, once the trailer left the show, any opportunity for members to buy the panels ended.

#### The Process and Decision Making

Work started on selling the panels about 3-4 weeks ago. A number of considerations were discussed including selling panels to Cal-Paca members. All of these were negated when Jeremy Menezes stepped forward and offered to buy the entire package, along with free moving and transferring panels to Orland. Sale of panels to the Glenn County Fairgrounds (Orland) has no impact either way on the Gold Country Gathering.

Basically, this is a huge success. About 250 panels will be delivered to Orland ("Glenn County Fairgrounds") by Menezes, which will host the Gold Country Gathering, and we dispose of a long-term burden, and we add \$11,000 to the Cal-Paca treasury.


**Next Step** 

The Committee recommends that the Cal-Paca Board of Directors approves the sale of the trailer/panels as presented here, even though it is after the fact. Either the President can call a special meeting or it can wait for its regularly scheduled meeting on about April 11. Cal-Paca should have its check after all the pieces for this transaction are completed.


